We cordially invite you to participate in the **Merchant Market** where small businesses and service vendors will have the opportunity to showcase their products and services during this year's Columbus Oktoberfest. The **Merchant Market** will be one of the many attractions as this longstanding Oktoberfest tradition makes its mark on Central Ohio attracting an estimated attendance of 30,000+ people. The Oktoberfest festivities are primarily held in and around 100-year-old historic covered pavilions. Exhibitors will be situated undercover within this beautiful authentic setting providing a great opportunity you won't want to miss!

- Entry Procedures: Complete the application form and return with your payment along with one photo of your overall booth display (please show full display) and 2-3 photos of your retail product(s) (label all photos). If you are a current exhibitor with Huff's with photos on file you do not need to submit additional photos unless your product(s) or display has changed, but you still must submit an application. Photos will not be returned unless requested with your SASE. Submitted photos may be used for advertising unless exhibitor indicates otherwise. Exhibitors selling retail items must provide a valid Ohio vendor's or transient vendor's license number.
- ◆ Fee Information: Booth fees must be paid with application. Your fee will not be processed if unaccepted or placed on waiting list. Cancellation fees apply. A \$35 fee will be charged for returned checks. Checks may not be deposited or credit cards processed until accepted into show. A \$15 late fee is applied if application is postmarked and received after 8/13/20.
- Acceptance: Exhibitors will be screened based on product and professionalism of overall display. Huff's Promotions reserves the right to accept or reject products at any time, and to change spaces or show lay-out to benefit the overall production of the show or to prevent competition or congestion.
- Application Status Notification will be sent by email.
- Display: Displays must be neat, tidy, professional and safe. Tables must be draped on all 4 sides, all the way to the ground with cloth table covers. Exhibitors with retail items must agree to man their booth during all show hours; absolutely no early dismantling. Tables & chairs available for an additional charge.
- Set-Up Information: Additional set-up information will be emailed closer to show date. By submitting a signed application, exhibitor agrees that all those working your booth will follow all show guidelines provided prior to and during the show.
- ◆ Advertising: Comprehensive advertising campaign for Oktoberfest includes television, radio, print, web, flyers & more.
- Misc: 1) The Oktoberfest will also include an Art & Craft Marketplatz designated for handmade art and craft items.
